4. Pre-bid meeting shall be held at Public Service Commission, Kamalpokhari, Kathmandu on 12:00 hrs. 14 October 2025
5. Interested bidders shall submit the electronic Bids through PPMO's website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12:00 hrs. 26 October 2025.
6. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14 hrs. 26 October 2025 at Public Service Commission, Kamalpokhari, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by minimum bid security amount, which shall be valid for minimum 30 days beyond the bid validity period. If bidder wishes to submit the Cash Security, the cash should be deposited in **Deposit Account Holder's Name: District Treasury Controller Office, Babarmahal, Deposit Account No. [120-1200-001-002524] at [Nepal Rastra Bank, Thapathali Kathmandu]** and submit the receipt of the deposited amount of cash along with the Bids.
