- 4. Interested bidders shall submit the electronic Quotation through PPMO's website www.bolpatra.gov.np/egp on or before 12:00 hrs. 9 October 2025. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14 hrs. 9 October 2025 at Public Service Commission, Kamalpokhari, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by minimum bid security amount, which shall be valid for 30 days beyond the validity period of the bid.
